# How did everything start?


#### How did everything start? A business fabric born in the 90s

- The very first companies created in our region, Panda in Bilbao and S21sec in San Sebastian, where also pioneers in Spain.
- Our entrepreneurial and innovative culture caused many others to be created from them.
- The startups ecosystem is vibrant and dynamic, every 3-4 months a new company comes from other regions or countries.
- The proportion of cyber technology startups (vendors>80%) is very significant compared to those born to offer services (providers).



How did everything start? 2017 - Many players but not an ecosystem

- Many companies but lack of understanding what all they were about.
- Absence of a common strategy.
- Inexistent dialogue between users and cyber companies.
- International promotion was "everyone for themselves".


How did everything start? The BCSC as an accelerator

• Telephone helpline for companies (24x7).



#### • Members:


- Basque Government (Region).

- Develop a common governance for the public sector, guides of good practice and elevate the cybersecurity maturity level.





Planning a limited set of aspirational scenarios.


Generating an intentional – not accidental – outcome.
