

Declaration of confidentiality, interests and conflicts of interest of the Governing Board members of the European Cybersecurity Industrial, Technology and Research Competence Centre (ECCC) and their alternates, permanent observers, the Executive Director and other ECCC staff that regularly attend Governing Board meetings

The undersigned Luca Nicoletti, Head of Industrial, Technology, Research and Educational Programmes Unit of the Italian National Cybersecurity Agency.

I hereby undertake to:

- 1. Act in the performance of my duties in the general interest of the European Cybersecurity Competence Centre.
- 2. - 4. To the best of my knowledge, the only direct or indirect interests I have in the Cybersecurity Sector are those listed below:

#### (a) Past activities:

I graduated in Physics at the University of Rome "La Sapienza" in 1996. After doing the military service as a Navy Officer, since 1997 I've been working in the IT field, being interested from the beginning in distributed systems and Web technologies. Between 1998 and 2000 I worked on Management Control Systems for important Italian companies in the Telecommunications and Energy fields. Between 2000 and 2013 I worked in Consip, first in the "Technological Architectures" area and then in the "System Solution" area. In 2013 I moved to Sogei S.p.A. in the "Technological Architectures and Services" area where I was responsible of the Technological Demand Management group. From 2007 to 2018 I joined server FP7/H2020 projects, serving as technical expert or technical leader. From 2019, I've worked in the Presidency of the Council of Ministers.

### (b) Current activities:

From 2021 I moved in the National Cybersecurity Agency, holding positions as Head of IT, Industrial programs, Research and Development, coordinating several working groups, including



the one for the writing of the implementing DPCMs of the Cybersecurity Perimeter, and the group that prepared the component of Mission 1 of the PNRR related to Cybersecurity. Over the years I have developed an in-depth knowledge of the public procurement code and tender procedures, as well as in the execution of complex contracts. My main fields of interest are Service Oriented Architectures, virtualization of systems and applications, Cloud Computing, Identity & Access management systems, topics on which I've produced articles and have been called to conduct seminars.

According to the Law Decree n. 82/2021, the National Cybersecurity Agency has taken up the role of National Coordination Centre pursuant to Article 6 of the Regulation, and its representatives shall be members of the ECCC Governing Board. Therefore, on 28th February 2022 I have been appointed by Prime Minister's Decree as the Italian representative at the Governing Board.
